1. There are no permanent customs controls carried in Germany at the borders to other member states.

2. Permanent customs controls are foresseen in Germany only for goods coming from third countries via german harbours and airports. Other customs controls are carried out in Germany with so called Mobile Control Groups. These Mobile Controls Groups are situated all over Germany.

3. Customs controls are carried out on the basis of risk management. Controls are **not carried out** on the basis of frontier passages, only. Mobile Customs Controls on the internal borders are carried out sporadicly and locally restricted.

4. There are about 220 customs officers active all over in Schleswig-Holstein . They are organized in 9 Mobile Control Groups. They are mostly active in the harbours of Schleswig-Holstein. Those harbours are the frontiers to third countires in Schleswig Holstein.

5. There is only one german mobile control group acitve at the internal border to Danmark. This group ist situated in Flensburg.

there are no offices at the internal borders to Danmark. The Mobile control groups are situated all over Germnany. Regarding the internal border to Danmark you can use the complete wording, especially that there is a Mobile Control Group in Flensburg situated. There is no Customs Office in Germany which carries out permanent customs controls at the border to Danmark. 8. juni 14:28 spørgsmål: Where are the officers which are opened 24/7 is that in flensborg kiel lubeck

No we don't have offices at internal border. We try to have customs officers at the border against Denmark 24-hours, but they belongs to the customs office in Malmoe.

### Polen

Der er tre svar fra tre forskellige:

30. maj 09:51 svar 1: Yes, we have Customs offices working 24/7 at internal border. However, they are not numerous. <u>Their role is</u> to provide customs clearance services, not to implement control/surveillance measures.

30. maj 15:30 svar 2: We have in Poland 2 customs branches working 24 hours a day (but with the exception of national/religious holidays, etc).

31. maj 13:20 svar 3: I am to inform you that Poland has such customs office - eg. situated directly at the internal border with Germany (Customs Division in Swiecko), operating 24/7/365.
